The Nicolás Fund for Education provides safe transportation for students from their village to the school in a nearby town which is approximately 40 minutes away and back home again at the end of the day. These students live in a remote agricultural region in the highlands of Guatemala where most young people do not have an opportunity to receive higher education beyond the sixth grade. Nicolás Fund for Education provides an annual regional teacher professional development workshop, and

Classes have been presented by local teachers, virtual presentations by SPU professors, and visiting teachers from the USA. Three teams from the USA travel to Guatemala with Nicolás Fund for Education each year. Two teams provide educational enrichment classes at Nicolás Christian school as well as local primary schools. The third team of the year attends the graduation of the Nicolás Christian School students. During each trip the team also visits the students and their parents in their communities to build relationships, pray for and encourage the families as well as address any questions or concerns about the NFE program.
